## **2012 CDA Award Winners**

### **Student Achievement Award**

### Mahmoud Al-Riffai

Mahmoud Al-Riffai has a B. Sc. Degree in Mechanical Engineering from Carleton University. After several years of job related activities in the mechanical engineering field he has shown a lot of zeal and enthusiasm in learning civil engineering; where he is currently a Ph. D. Candidate at University of Ottawa. Mahmoud's research project is investigating the effects of the geotechnical properties of embankment dam on the progression and size of dam breach caused by over topping. So far he published nine technical papers, and for the high quality of his research, Mahmoud has been selected to serve as a member of ASCE/EWRI Task Committee on Dam/ Levee Breaching.

### **Published Paper Award of Excellence**

Jason Bond, Don Kim and John Fletcher

The 2012 Published Paper Award was awarded to `Jason Bond, Don Kim and John Fletcher for their paper "A Study of the Use of GPS Sensors for Structural Monitoring of the Mactaquac Dam" Presented at 2011 CDA annual Conference. The paper discusses the application and adaptation of global positioning principals and equipment to measure movements in dams. The paper also discusses the drawbacks and challenges that need to be addressed to improve current state-of-practice.

### Peter Halliday Award for Service Bob Barnes

Bob Barnes has been an active and willing participant in the affairs of the dam community for decades. He has been a member of CANCOLD, participating in the early discussions that lead to the creation of the Canadian Dam Safety Association (CDSA), where he served as the Atlantic Region representative. Bob and Peter Halliday were members of the task group responsible for the Niagara Declaration that resulted in the merger of CDSA and CANCOLD into the current CDA. In the CDA, Bob served as Newfoundland Director and later as CDA president. He served as chair and member of the organizing committees for the two CDA conferences held in Newfoundland

### **Garth Haack**

Before joining the CDA Board of Directors as Saskatchewan Director from 2000 to 2004, Garth volunteered to serve as a member of the organizing Committee and Treasurer of the 2000 CDA annual conference. After completing two terms as Director for Saskatchewan, he served for three years as a member of the "Internal Financial Review Panel," a group appointed by the membership to review the CDA books.
